Ticket Sales Tickets will go on sale From Thursday 8th March.

The debutante's/partner's parents will be able to pick their family table from the side which their children are being presented, once payment for a minimum of 8 tickets has been received. Debutante's family will be able to choose one table from those marked as Debutante family tables and Partner's family may choose one table from those indicated for partners. Other tables will be allocated and will be kept as close as possible to the family tables. If you have any special table seating requirements (including highchairs) must be marked your Table Allocation sheet which will be distributed approximately three weeks prior to the deb. Table allocations will be finalized two weeks prior to the ball with ticket sales after this date only being available if they can be accommodated on the floor plan. **No cheques will be accepted one week prior to the ball.**

Guardian declaration

Parents must sign a form accepting guardianship for all guests under the age of 18. As ID is not requested, this form must be signed whether you will or will not have minors amongst your guests. Ideally this will be signed at the meeting but if you miss signing it here then I ask you to call in at one of the practices to sign it.

This must be signed for the child to participate. The person signing must be in attendance on the night but does not necessarily have to be the participants parent but must be a Parent. This form cannot be signed by a person who does not have the experience of children. This form cannot be sent home as I have no way of verifying signature.
